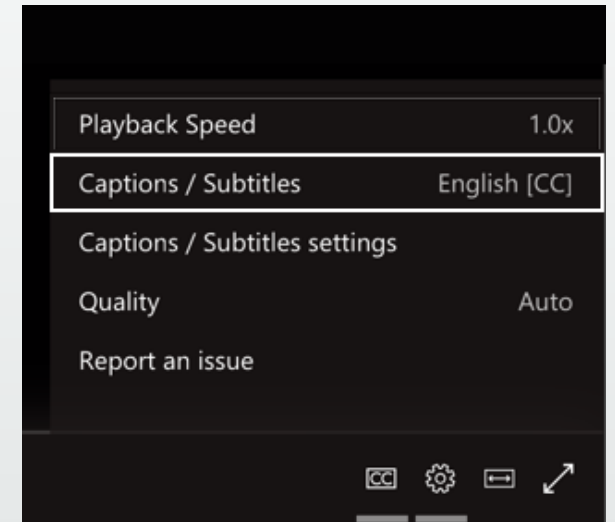

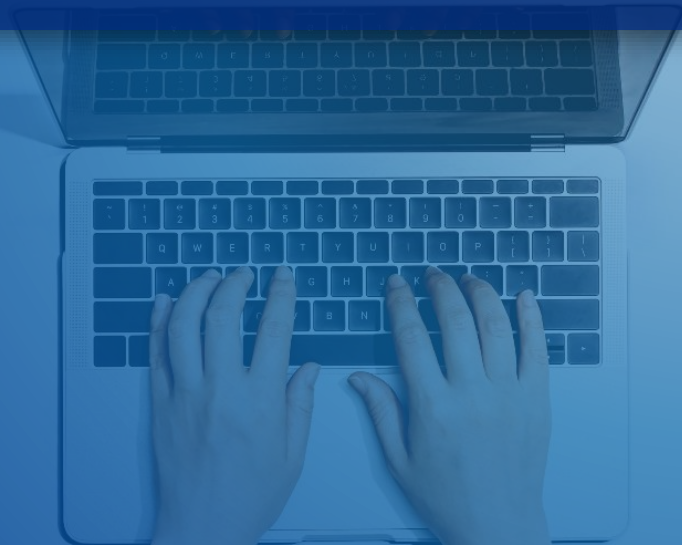

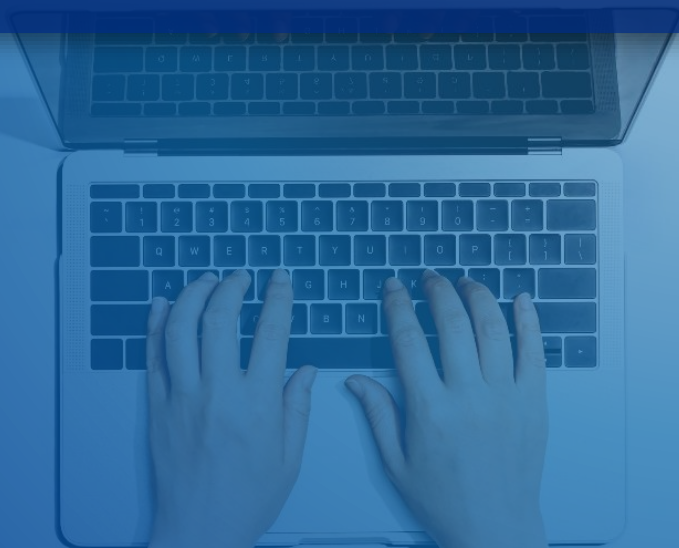

# Venue Owner Checklist (Blayne Tucker):

- Your 2020 and 2019 financials BY MONTH
- Your 2019 tax returns
- Your DUNS number (for link see next slide)
- Support for DUNS/questions: <https://support.dnb.com/?CUST=GOVTDUNS>
- Active SAMS account (for link see next slide) with CAGE Code assignment. (if you do not have a CAGE Code, you will be assigned one during the SAMS registration process). SEND THE NOTARIZED letter (look for instructions in your registration confirmation email), it's probably not necessary, but to be cautious, do it.
- Having difficulty with SAMs? File an incident report, or call [866-606-8220](tel:866-606-8220)
- Register for an account at [grants.gov](https://grants.gov) (Only takes a few minutes, but requires SAMS & DUNS #)
- FLOOR PLAN (detail required yet to be determined)
