DECLARATION OF TEXAS RESIDENCY**

Production companies applying to the Texas Moving Image Industry Incentive Program for an incentive payment that is based on wages or salaries paid to Texas residents for work performed on a qualified production in Texas must complete this declaration of residency for each resident. The production company must retain this form and submit a copy to the Texas Film Commission when submitting verifying documentation for the Incentive Program.

SECTION III – RESIDENCY VERIFICATION – *For the purposes of the Incentive Program, to be a permanent resident of Texas you must be domiciled in Texas. Your domicile is your permanent home; it is the place to which you intend to return after any temporary absence. You can have only one domicile. A change of domicile is established only by establishing a physical presence in a new location with intent to abandon your old domicile and make a home in the new location permanently or indefinitely.*

You must present one of the following documents to a production company representative to verify the start of your permanent residence in Texas. If you cannot provide one of these three forms of evidence for the time period required, you cannot be considered a Texas resident.
