

## State of Texas - Texas Film Commission DECLARATION OF TEXAS RESIDENCY

*Production companies applying to the Texas Moving Image Industry Incentive Program for an incentive payment that is based on wages or salaries paid to Texas residents for work performed on a qualified production in Texas must complete this declaration of residency for each resident. The production company must retain this form and submit a copy to the Texas Film Commission when submitting verifying documentation for the incentive program.*

A change of domicile is established only by establishing a physical presence in a new location with intent to abandon your old domicile and make a home in the new location permanently or indefinitely.*
