## **Human Trafficking Prevention Month Recap**

Governor Abbott <u>issued a proclamation</u> recognizing January as Human Trafficking Prevention Month in Texas. Below are just a few of the activities that took place in our state to kick off this new year with a renewed focus on ending trafficking.

## **Bullock Museum Exhibit Launch**

On January 9th, the Bullock Texas State History Museum opened a new exhibit on human trafficking. *Not Alone* educates visitors about human trafficking and gives them a sense of hope and empowerment in combating the issue. Week of Prayer to End Human Trafficking

GRACE hosted the statewide Week of Prayer to End Human Trafficking from January 11th through January 17th. The week launched with a virtual interfaith event, including remarks from First Lady Cecilia Abbott, DFPS Commissioner Jamie Masters, prayer, and a panel discussion with a diverse group of faith leaders. Here are just a few highlights of activities shared from GRACE members:

- Many members of Congregation Agudas Achim watched the virtual launch event.
   The community also utilized many of the Jewish prayers throughout the week both in worship and to share over social media.
- The <u>Freedom Church Alliance</u> organized daily prayer events at locations across Houston. Individuals followed safety protocols to gather and pray for daily intentions and an end to human trafficking.
- The Texas Catholic Conference of Bishops created a Catholic toolkit for the week of
  prayer, which included social media/print graphics, prayer intentions, and calls for
  actions. The toolkit was shared with bishops and constituents across the state. The
  Diocese of Austin shared this resource with all of its priests and equipped parishes
  with social media infographics, bulletin inserts, and prayers for use at mass.

## Texas Human Trafficking Prevention Coordinating Council Webinar Series

In May 2020, the Texas Human Trafficking Prevention Coordinating Council released a <u>strategic plan</u> to address human trafficking in Texas. During Human Trafficking Prevention Month, the Coordinating Council launched a webinar series to cover each of the 5 main goals in the strategic plan: PREVENT, PROTECT, PROSECUTE, PROVIDE SUPPORT and PARTNER.

Department of Justice's Office of Violence Against Women announces the Fiscal Year 2021 Transitional Housing Assistance Grants for Victims of Domestic Violence, Dating Violence, Sexual Assault and Stalking Solicitation

This funding opportunity seeks to support programs that provide 6-24 months of transitional housing with support services for victims who are homeless or in need of transitional housing as a result of a situation of domestic violence, dating violence, sexual assault or stalking; and whom emergency shelter services or other crisis intervention services are unavailable or insufficient.

Estimated Total Program Funding: \$37,000,000. Award Ceiling: \$500,000. Award Floor: \$300,000. **Due Date: March 2, 2021**.

# For Schools and Child Serving Agencies: PROTECT Texas Prevention Education and Training

3Strands Global Foundation is partnering with the Child Sex Trafficking Team to generously offer Texas schools and youth-serving organizations free access for one year to online training modules to help those working with youth better identify and respond to human trafficking. Participants completing the training will also have access to an age-appropriate, trauma-informed curriculum to teach youth. PROTECT recently launched an additional training for Texas school board members to meet the requirements of HB 403. These resources are available for free through February 2021, and individuals will need a work e-mail account with a school or youth-serving organization to register.

## **Protect**

On January 9th, the Bullock Texas State History Museum opened the *Not Alone* exhibit. The exhibit centers on a series of questions that guide visitors to understand what human trafficking is and explore the human stories and current landscape of sex and labor trafficking. Audiences will gain awareness of who can be a target, the tools and techniques traffickers use to target individuals and keep them captive, and the roles healthy relationships and social media play in trafficking. The exhibit is the first of its kind and provides age-appropriate prevention messaging for middle school and up. We applaud the leadership of the Bullock Museum for their vision in creating this exhibit as well as the advisory committee, especially the incredible survivor leaders, who helped guide them. *Not Alone* will be on display in Austin through May 30, 2021 with hopes of a future traveling exhibit. ## Recover

One of our CSEY advocacy programs was dispatched to meet a survivor, Keisha, at the hospital. Due to her medical condition, Keisha was unable to talk and appeared agitated when the advocate entered the room and disinterested when advocacy services were explained to her. However, when the advocate gave Keisha a survivor bag, her whole demeanor instantly changed. She put the chapstick on her lips and lotion on her hands and seemed very interested in the journal. The advocate let Keisha know that she cared about her and wanted to visit her again. Keisha then wrote on paper that she wanted the advocate to come back next week. At the next visit, the Keisha lit up when the advocate came into the room. She showed her advocate several pages of the journal where she had written about her experiences. Keisha still wasn't able to speak so the advocate sat with her and they colored together in an adult coloring book. Although their time together was mostly silent, Keisha seemed to be comforted by the advocate's presence. She said she felt alone in the hospital and was grateful to have a friend to sit with her.

### **Support Healing**

Amy entered one of our residential providers last summer and excelled, becoming a mentor to peers on campus. She worked hard in therapy and in the program in general, learning new coping skills. Amy graduated from the program just a few months later and is now attending her senior year of high school and planning to play college basketball in the Fall.

## **Bring Justice**

Seventeen year old Maria was referred to one of our CSEY advocacy agencies by a county juvenile probation department in 2019. Maria experienced repeated runaway incidents, but the consistency of her advocate's support empowered Maria to finally find the courage to share information that led to the identification of her trafficker. Maria has
