Summer is upon us and off to a great start! The Texas Legislature concluded its session in June with the passage of significant anti-trafficking legislation. We are pleased to report that among these new laws are provisions that enhance protections for children and strengthen the state's overall response to human trafficking.

On August 28, 2025, from 11:30 a.m. to 1:00 p.m., the Child Sex Trafficking Team (CSTT), in collaboration with the Office of the Attorney General, will present the August installment of the CSTT webinar series. This session will provide a comprehensive legislative update focused on human trafficking. Please be on the lookout for your invitation to register.

This spring, new Care Coordination Teams launched statewide to support children and youth at risk of, or experiencing, commercial sexual exploitation or sex trafficking. In this newsletter we highlight the official launch of Care Coordination in McLennan County and celebrate with them that children and youth in their community have access to a robust system of care as they heal and seek justice.

Summer is a great time to embark on training and we are providing you with information about several training opportunities. We encourage you to consider training in these areas and to share the resources listed in this newsletter with your network.

June is Internet Safety Month

As technology continues to evolve, so do the tactics used by traffickers to exploit children and youth online. Social media platforms, messaging apps, and other digital spaces are increasingly being used to target vulnerable individuals for exploitation and extortion.

Addressing these risks begins with education. By promoting internet safety, equipping families with the tools to recognize potential threats, and encouraging safer digital practices, we can help protect children and youth in online environments.

Below is a list of free, accessible resources designed to support online safety for children, youth, and their families.

- [NCMEC NetSmartz](#) | NetSmartz is an online safety education program that provides age-appropriate videos and activities to teach children to be safer online.
- [Take It Down](#) | Take It Down is a free service that assists individuals to remove sexually explicit images from the internet that were taken when under the age of 18.
- [Internet Safety - ICAC](#) | The Internet Crimes Against Children Task Force Program has found high quality and effective internet resources which will help you and others get better informed about the current dangers and challenges in your effort to protect children across this country every day.
- [Department of Homeland Security: Blue Campaign](#) | DHS' Blue Campaign is a national public awareness campaign designed to educate the public, law enforcement, and other industry partners to recognize the indicators of human trafficking. DHS offers several safety tips to keep in mind when using the internet, including social media.
- [Safe Online Surfing Internet Challenge](#) | This FBI website offers a free and interactive way for children in grades three through eight to learn about cybersecurity. Through engaging games, it covers essential topics ensuring kids become savvy digital citizens while navigating the latest online threats.
- [CyberTipline](#) | This tip line is the nation's centralized reporting system for the potential or suspected online exploitation of children. Members of the public and

electronic service providers can make reports of child sexual exploitation by submitting an online form or by calling 1-800-THE-LOST.

Rooted in the [Texas Model of Care Coordination for Commercially Sexually Exploited Youth \(CSEY\)](#), the program promotes sustainable autonomy, healing, justice, and stability for children and youth at risk of or recovering from exploitation.

McLennan County's Care Coordination Team's shared vision is to have a high quality community model where every exploited child/youth is recognized, supported, protected, and receives justice. This vision will be accomplished through their mission to recognize, recover, protect, restore and bring justice to commercially sexually exploited and at-risk children/youth through collaborative response and long-term support.

The program brings together a coordinated network of trauma-informed providers to deliver tailored and holistic support. This launch marks a significant step toward protecting and empowering vulnerable youth in McLennan County.

Commercial Sexual Exploitation Identification Tool (CSE-IT) Training for Law Enforcement & Criminal Justice Personnel

This CSE-IT training will enable law enforcement and criminal justice personnel to accurately identify indicators of child sexual exploitation, without relying solely on youth self-disclosure, alerting the need for investigation. This training will also provide a framework of language and understanding that will improve their communication with service providers and partners doing collaborative work in human trafficking prevention and identification. This training is eligible for TCOLE credit hours.

Child Sex Trafficking: From Suspicion to Disclosure

National Criminal Justice Training Center

Learn basic techniques and strategies to enhance the likelihood of obtaining information from possible victims of child sex trafficking. Compare and contrast typical child sexual abuse cases with child sex trafficking (CST) cases and address the different points of entry into the criminal justice and welfare system for CST victims. Understand various disciplines' roles and responsibilities and how they can contribute to a positive outcome of the CST case. Examine question strategy, interview dynamics, language use, and interview suggestions. Discuss the business model of child sex trafficking as it relates to a variety of crimes, including the use of child sexual abuse material (CSAM).

Child Abuse: From Suspicion to Disclosure

Learn the best approach with children who are alleged victims of child abuse in the initial phases of a case, after a concern has been identified. Develop the basic skills and techniques necessary to engage a child in such a way as to minimize suggestibility but still provide support, beyond what is taught in a First Responder Training. Review best practices in identification of a concern and learn to engage these children in a way that maximizes positive case outcomes and minimizes potential behaviors that can hurt cases.
