

# Anti-Human Trafficking/Healthy Relationships Efforts in Texas

## Texas State Agency Initiatives and Responses (2016)

### Government Organizations

- Department of Family and Protective Services
  - Texas 2nd state to sign a Memorandum of Understanding with the National Center for Missing and Exploited Children, so that when any foster child went missing it would be immediately reported
  - Child Abuse Hotline (Statewide intake staff)
  - A public website created to provide information on trafficking
  - All youth ranging from 14-21 years old receive human trafficking training at all state and regional conference seminars
- Office of the Secretary of State
  - Working with OAG and other Task Force partners to develop the **Human Trafficking Prevention Business Partnership** to engage participating corporations and other private entities
    - **Children at Risk** worked on this Partnership as well
- Supreme Court of Texas Permanent Judicial Commission for Children, Youth and Families (Children's Commission)
  - Focuses on providing information to judges and attorneys responsible for child welfare cases to raise awareness of human trafficking and how it affects children involved with the child welfare system
  - **Family Focused Treatment Association**
- Texas Alcoholic Beverage Commission
  - TABC trained on how to identify potential human trafficking victims
  - Mobile App: TABC Mobile, which enabled consumers to report suspected human trafficking

### Non-Governmental Organizations

- Children at Risk
  - Recently released ***The Sex Trafficking Marketplace: Addressing Demand through Legislation and Tactics***
    - Focuses on the demand for commercial sex in Texas and includes an analysis of commercial sex legislation and provides information on future research and policies
  - Hosts a **statewide Human Trafficking Summit**
    - Key Theme:
      - Importance of a protective response for child sex trafficking victims and issues related to addressing demand
  - Looking to increase their Human Trafficking Resource Database
  - **The CEASE (Cities Empowered Against Sexual Exploitation)**

- Network is a collaboration of 11 pioneering cities across the country committed to innovating, testing and sharing strategies to deter the demand for commercial sex

  - Presented at the **Nuestra Voces national conference** on human trafficking and trauma in the Latino Population and at the **Latinos Against Domestic Violence conference**
- Allies Against Slavery
  - Core partner on the **Texas Slavery Mapping Project**
  - Designed an electronic screening tool **Tier One Screener** to more rapidly and effectively identify possible victims of domestic minor sex trafficking
- University of Texas at Austin Institute on Domestic Violence and Sexual Assault
  - Helps gather comprehensive data from across the state
  - The **Texas Slavery Mapping Project** is a partnership between UT and Allies Against Slavery to gather information about human trafficking across the state
  - The team works in collaboration with the **Child Sex Trafficking Team at the Criminal Justice Division** of the Office of the Governor.

#### [Teens Tackle Human Trafficking in Houston – Houston Public Media](#)

- A partnership with **United Against Human Trafficking** youth are putting together **hygiene kits** that will be distributed to vulnerable populations and attending awareness workshops
- **2016 University of Texas report estimates over 300,000 Texans are currently being trafficked, including 79,000 youth victims of sex trafficking**
- Lead Outreach and Education Specialist for United Against Human Trafficking, Kaylen Runyan, said it's critical to educate middle and high school students about this issues because they are the most vulnerable
- Children at Risk Advocacy Group published a map earlier this year showing that many suspected illegal massage parlors are located in close proximity to Texas Schools – **35,000 Texas children attend school within 1,000 ft. of a suspected illegal massage business**

*Using Music, Movies, Video Games and School Curricula to promote **healthy relationships***

- Teaching 11 to 14 year olds about healthy relationship
- Rallying entire communities to promote healthy relationships and prevent teen dating violence in middle schools
- Creating innovative prevention model
- Comprehensive plan that focuses on: involving education, policy change, community outreach and cutting-edge social marketing campaigns

- They testified or supported over 50 pieces of legislation in committee hearings

### [The University of Texas Health Science Center at Houston: Me & You – Building Healthy Relationships](#)

*A classroom and computer based curriculum for 6<sup>th</sup> grade students developed by researchers at the University Of Texas School Of Public Health.*

- Teach youth the importance of heaving healthy relationships and how to make good decisions in their relationships with peers, friends, family and future dating partners

- Curriculum was developed using intervention mapping (a framework for developing health education interventions using behavioral science theory and empirical evidence)

### [Texas Medical Association: Out of the Shadows](#)

*Four goals to combat **sex trafficking** of minors: educating physicians, improving patient care, promoting prevention and raising awareness.*

- Creating a set of protocols for local hospitals and clinics to follow when a health care worker identifies a sex trafficking victim
- **Working to create a special room for young victims to stay for 72 hours while social services professionals make long-term arrangements**
- Worked with Voice of Hope and OneVoiceHome, a shelter under development to primarily assist girls ages 11 to 17

### [The Heart of Texas Human Trafficking Coalition](#)

*Multi-disciplinary, collaborative effort to combat **human trafficking** in the Heart of Texas region*

- 1) Increasing Community awareness for the prevention and identification of human trafficking victims
  - 2) Increasing investigation and prosecution of human trafficking cases at local, state and federal level
  - 3) Providing coordinated, comprehensive, trauma-informed services to the individualized needs of human trafficking victims
- Meets for quarterly roundtables to share information and increase knowledge of trafficking-related topics
  - Bi-monthly subcommittees also meet to accomplish tasks in specific areas
  - These subcommittees are:
    - Prevention
    - Protection & Prosecution
    - Partnership and Program Evaluation

### [Traffick 911](#)

*Exists to free youth from **sex trafficking** with a three-prong strategy of prevention, identification and empowerment*

- Has a youth prevention program called **Traps**
  - Teaching youth how to #BeSmartStayFree from trafficking by understanding their tricks, traps and lures
- Provides direct services such as crisis response, case management and volunteer advocate program to child sex trafficking victims in North Texas

### United Against Human Trafficking

- *Front-line Professional Education Program*
  - Healthcare providers, First-responders, Educators, and other professionals who are more likely to come into contact with a victim while in captivity
  - Programs specifically tailored to different professions and how they can fight human trafficking while at work
- *Youth Programs*
  - Creating conversation within the community about the specific vulnerabilities of youth and how they can make decisions that will keep them safe
- *Direct Outreach Program*
  - Focused on engaging the populations most vulnerable to falling victim of human trafficking

### UnBound Now (Waco, TX)

*UnBound is activating Texas communities to fight **human trafficking** through: Prevention, Professional Training and Survivor Advocacy*

- **Prevention**
  - Educating and empowering youth
  - Spreading awareness through citywide outreaches
  - Providing human-trafficking presentations to local communities
- **Professional Training**
  - Provides professional training to lawyers, medical professionals, educators, and social service providers
- **Survivor Advocacy**
  - Providing for immediate needs
  - Offering support to caregivers and volunteering services
  - Connecting with aftercare programs to help each survivor through their restoration process

### Rescue Houston

*24/7 Hotline to provide immediate response and rescue for victims of **sex trafficking** and sexual exploitation*

- The hotline deploys exit teams and provides trained advocates that are available to victims of sex trafficking and sexual exploitation 24 hours a day, seven days a week, and 365 days a year.

### Human Rights Initiative

*Dallas-Based Non-Profit Assisting **Survivors of Violence** all around the world*

- HRI of North Texas provides legal and support services to refugees and immigrants who have suffered human rights abuses
- Advocating for justice and promoting international human rights for all

### **THORN (Ashton Kutcher = Chairman/Co-Founder)**

*A charitable organization using software to help identify and locate **trafficking victims**. THORN currently works with law enforcement agencies worldwide to stop epidemic of trafficking and exploitation.*

- Uniquely equipped non-profit
- More than 350 volunteers and members of the tech community
- 20+ International NGO partners and 40+ tech partners
- Serving over 5,000 law enforcement officers in 50 states and over 18 countries.
- One tool available through THORN is **Spotlight** which helps 4,000 law enforcement officials in 900 agencies prioritize their caseloads
- “**Defend Happiness**” Campaign through T-Shirt Sales, 100% of proceeds raised donated
- **Found 6,000 Trafficking Victims Last Year**

### **Polaris Project (Many states work with this project)**

*Polaris uses data-driven strategies to prevent and disrupt **human trafficking***

- Serving victims and survivors through 24/7 national human trafficking hotline
- Building one of the largest public data sets on human trafficking in the US
- Turning knowledge into action, designing targeted strategies that change entire systems tailed to specific subtypes of trafficking and specific industries
- Enlisting law enforcement and other public and private-sector partners, moving those strategies into the real world to support survivors, prevent and disrupt human trafficking

### **Red X Social Media Campaign (2017) (End it Movement)**

*Facebook, Instagram and Twitter, greeting members with a heavy smattering of red Xs as part of a broad social media campaign to raise awareness about **human trafficking and slavery**.*

- Initiative was part of **Shine a Light on Slavery Day**, which was created by **End It Movement** (an organization that brings awareness, prevention and rescue efforts to fight against the global problem)
- **End It Movement**
  - A coalition of the leading organizations in the world in the fight for freedom
  - Option to build your own “End It” poster
- Shine a Light on Slavery Day is annually on February 23<sup>rd</sup>.

*Campaign was designed to educate students on the building blocks of **healthy relationships**.*

## 2. **Alaska** (Collaborations)

i. *What do they do?* Links local, state and federal resources, and brings law enforcement and service providers together in a common cause. Increase awareness of Human Trafficking. Continuing the work initiated in 2012 by the Alaska Task Force on Crimes of Human Trafficking. Hotline and promotional flyers.

b. [State of Alaska Task Force on the Crimes of Human Trafficking, Promoting Prostitution and Sex Trafficking](#)

i. *What do they do?* Look at the prevalence of crimes of Human and Sex Trafficking. Assess the current services available to victims of Human Trafficking. Make recommendations for ways to further assist victims. Conduct a high profile media campaign. Educate youth. Encourage establishment of safe shelters, both short and long-term.

## 3. **Arizona** (Collaborations)

i. *What do they do?* Develop a comprehensive and coordinated victims' service plan. Evaluate and report to the governor statewide data on Human Trafficking.     - i. *What do they do?* Action Line: request information, volunteer, ask questions or submit anything in the area that may be Human Trafficking). Events Calendar on website with public events and specialized training opportunities. Option to subscribe for email updates and notifications.

  - c. [Los Angeles Human Trafficking Task Force](#) – LA Sheriff’s Department
    - i. *What do they do?* Investigate high-priority trafficking crimes-particularly the Sex Trafficking of minors. Bringing together federal, state and local leaders to help address the problem. Emphasis on prosecutors, investigators, justice system partners, service agencies and victim advocates to work together to provide care to victims, and to ensure strong investigations and prosecutions.
  - d. [Central Valley Human Trafficking Task Force](#) – Justice Coalition
    - i. *What do they do?* Prayer: prayer incorporated into all they do, locally focused prayer guide resource, monthly prayer gathering. Community Education: training youth, adult business professionals and agencies.   - i. *What do they do?* A collaboration of agencies. Identify and rescue victims of human trafficking. Proactively investigate, identify, apprehend and prosecute those engaged in human trafficking. providers, law enforcement and practitioners and mobilization groups collaborate to improve the response to trafficking.

- c. [Washington State Task Force Against the Trafficking of Persons](#) – Department of Commerce
  - i. *What do they do?* Measure and evaluate the resource needs of victims and survivors and the progress of the state in trafficking prevention activities. Identify available federal, state and local programs that provide services that include: health care, human services, housing, education, legal assistance, job training or preparation, interpreting services, classes in English as a second language and victim’s compensation. **Review the statutory responses and analyze the impact/effectiveness of strategies.**
- d. [Commercially Sexually Exploited Children Statewide Coordinating Committee](#) – Washington State Office of the Attorney General
  - i. *What do they do?* Addresses increasing protections for exploited youth by examining local and regional practices and incidence data and making recommendations on statewide laws and practices.

  - i. *What do they do?* Prioritize meeting the health, safety and survival needs of victims, ensure services are accessible, treat victims with sensitivity and respect, provisions of information of victims’ statutory rights, service options and the full range of choices available to victims. **Collaborate with victims** to identify and pursue strategies and services to promote long-term stability, financial security and independence to make choices for a healthy future.
